## Notes from the Board

#### **Returning Membership Applications (RMAs)**

Following the Board's approval of the annual budget, Annual Dues for the 2022 – 2023 SBSRA Membership Year were set as follows:

Returning Members	\$ 90

At this time, the period for submitting RMAs is now open. If you wish to return as a member for another year, please do the following:

- 1. Submit a RMA, <u>https://sbsra.org/association/rma/</u>. Please note we have added a couple of questions about our other officiating activities. This is for information only and will not be a consideration for reacceptance of anyone as a member of SBSRA,
- Submit payment using PayPal, check or by deduction from tournament fees, <u>https://sbsra.org/association/paypal/</u>. Note, any dues not received or deducted by July 31 are subjected to a late fee of \$20.
   Members who brought in another member are eligible to receive a free year of membership pursuant to our New Membership Initiative (NMI) program, following receipt of the new member's dues for the subsequent year. NMI recipients should receive notification of their

eligibility soon.

Members have received email notifications that their certificates would be expiring soon. One needs to ensure the refresher course is being taken (for longer term members this is likely the "Third Refresher") and not the initial course. Although it is not difficult to complete, it requires an hour or so to complete. Not all members received a reminder email, but it needs to be done before the current one expires to receive games. To check if you need to complete a SafeSport refresher, please check your certificates in your Cal South profile.

#### Match Reports

Our referee duties do not end when we blow the final whistle. We usually need to complete a match report. This is usually in the form of a printed document provided by team managers. We need to be aware of league requirements and ensure we comply with them.

In particular:

- 1. For all ZogSports games, submit scores by email within 24 hours <u>to the assignor</u>, including date, field, game times and team names in your email.
- For all SBPSL games, complete the Line-Up Cards with match result, misconduct, and all other information requested. Ensure the names and jersey numbers of carded players are legible. Retain the SBPSL ID card of all players and Managers sent off. Submit completed Line-Up Cards by email on the same day as the game <u>to the assignor</u> by attaching a scan (in PDF format, preferably) or a picture of the report to your email.

#### Futsal

As previously reported, we will begin to provide Futsal Referee Services for the next LA Galaxy Sports Center Futsal league session on June 6 through August 29. # All Referees MUST have attended one of these training dates and certified with Cal South to be able to officiate in this league.

Additionally, as previously communicated, members are required to be available and to officiate other mid-week games to be assigned Futsal games.

#### **Availability and Blocks**

All members have an obligation to minimize the number of times we decline games after we are assigned. As independent contractors, we all are entitled to accept assignments wherever we can get them. However, in fairness to all assignors; Gabriel and Veto here, and others elsewhere, we are all requested to block the days that we are unavailable to the applicable assignor(s) ahead of time. Choosing who we want to work for on specific days is perfectly fine, waiting to see which games you are assigned and then declining the less favorable ones is simply not acceptable. The extra work it creates for the assignor, is more than most of us can imagine. **Please block ahead of time!** 

#### **Off-Season/Quiet Time**

Say what?!?! Despite what many may think, we are hugely busy – over 100 games each weekend. We need everyone to be available! Please open your blocks with reasonable mileage limits.



#### New Ratings System

Observations/Evaluations are underway! We have begun to implement the new system and a number of referees have already been observed. Our Vice President, who is responsible for the Ratings of Members, will be reporting on progress and the results of the evaluations, in a general way, not of individual members, at our monthly General Membership Meeting.

As with any new system, we have had some challenges but we are continuing to work on this to create and effective and transparent system.

What is CORE?

Center of Referee Education (CORE) is a program established by Cal South State Referee Committee (SRC). It is open to all USSF certified referees. It consists of physical trainings & lectured meetings for referees who are looking to be at some point be at the elite level of Cal South.

Emphasis is placed on both physical fitness and classroom instruction. Referees attending this event are expected to come prepared with material for physical fitness (i.e.: tennis shoes, whistle, cards, flags) as well as material for classroom (i.e.: FIFA Laws of the Game, Guide to Procedures, paper and pen).

While these trainings are for referee self-development, please note that Regional or Grassroots Elite certification or recertification require referees to attend at least 5 CORE trainings per year. The same requirement applies to instructors and assessors.

Please be reminded that this is an important meeting as nominations for 3 Board Positions and proposed Bylaws Amendments will take place at this meeting.

#### Two Person (Whistle) Referees

IFAB and USSF prohibit the use of the two-person referee system. While many of us may use this system for high school and middle school games, it may not be used by any USSF-sanctioned games that we do. If any doubt, unless assigned to do this by one of our assignors, please **DO NOT USE THE TWO-PERSON REFEREE SYSTEM** unless you have been assigned by one of our Assignors to be on a two-man crew.

Conversely, if you have been assigned as a <u>**TWO-PERSON REFEREE CREW**</u> for <u>**non-USSF-**</u> <u>**sanctioned games**</u>, please honor the assignment regardless of what your assigned partner may say. If there is an issue, please contact the appropriate assignor – Gabriel for weekend games and Veto for weekday games.



#### Supplemental Reports

Due to ongoing challenges, we continue to provide the following guidance for all members:

Please be reminded that whenever we have serious situations, a supplemental report is required:

- The Cal South Supplemental report form, on the SBSRA website, must be used,
- The report is required to be prepared ASAP, within 24 hours for <u>all serious situations</u>, including:
  Red cards
  - Serious injuries (paramedics called, player taken to emergency room/hospital), attended to by the trainer or,
  - Game terminations, etc.,
- Take a **copy of the Match Report** to prepare the Cal South incident report,
- Use **simple language** and include the **facts of the incident** only:
  - When date and time, point in the match
  - Where venue and specific location on the field
  - Who was involved? The player's name, number, and team and,
  - What happened? Don't speculate, just note what you saw.

Note there is no "**Why**." Not our job to speculate on why someone did what they did and we should not include a diagnosis of the injury, even if we have the ability to do so.

- **Do not use abbreviations**, only use **language in the Laws of the Game** to describe the applicable misconduct.
- **Call the Assignor**, after any game that requires an incident report, so he is informed when the league calls him.
- **Submit the supplemental report** to our Member-At-Large (MAL) and the Assignor (and Co-Assignor if the game was assigned by the Co-Assignor) who will review the report and possibly suggest edits.
- Following submission of the incident report to the MAL, please call him to ensure it has been received if you have not received an **acknowledgement of receipt within 2 hours**.
- Following review and approval of the report by the MAL and Assignor, the Assignor submits the final report to the applicable league.
- If you have kept ID cards, not required for all red cards, the card(s), together with copies of the match report and incident report must be sent to the applicable league administrator by the end of the first business day (likely Monday) following the game.
- The **importance of this process** cannot be stressed strongly enough! These reports are really needed by the leagues and everything we do needs to **reflect our professionalism** as individuals and as a referee association.

#### **Monthly Referee Ouick Tip**

Following is this month's Referee Quick Tip. Members are encouraged to submit quick tips that work for them for consideration for future issues.

#### What did I forget?

Have you ever arrived at game assignments with all the large items – equipment bag with your shirts, AR flags, various body-parts braces, hydration, snacks, sunscreen, a chair, protection from the sun etc.,



only to discover you have left your little bag at home? You know, the bag with coins, whistles, badges, referee wallet/book with your match notes and cards...

Bruce Ashton confesses this has happened to him. The solution? He has another small bag with the items listed above in his car at all times – glovebox, trunk, wherever makes sense. Be like Bruce!

#### **Annual General Meeting**

Our AGM is scheduled to take place on Tuesday, June 28. There are several items to be decided on and important matters relating to the AGM:

- 1) Location, location, location as voted on by you the members in attendance at the April General Membership Meeting, we will hold the AGM at a restaurant, within close proximity to North High, to be determined.
- 2) Board Elections every year, we have multiple Board Positions up for election. This year there are three positions we will be voting on:
  - a. President,
  - b. Secretary
  - c. Member at Large

Each position requires a certain level of diligence and continuing time investment to be effective throughout the two-year term. The time demands are different for each position vary from time to time but greatly exceeds the time needed to attend the 2 monthly meetings – Board and General Membership. We have a relatively small board, and each member must be a fully contributing one for our Association to run effectively and efficiently.

Following is more detailed information about the duties of each of these candidates:

a. President,

What the Bylaws say:

- a. Perform the duties incident to this office and such other duties as may be required by law. He/she shall be the Association's official public spokesperson.
- b. Administer the business of SBSRA with the collaboration and consent of the BOD.
- c. Preside at all meetings of the Membership and of the BOD.

#### In reality:

In addition to the duties specified in the Bylaws:

- a. Be the primary Association contact for the following:
  - i. Existing Members and Potential Members,
  - ii. Existing Customers and Potential Customers,
  - iii. Cal South,



- b. Respond to "Referee Requests" submitted through the SBSRA website,
- c. Provide Support to all Board Members to ensure all duties are carried out in the best interests of the Association,
- d. Negotiate and administer all new opportunities to provide referee services to the soccer community in consultation with the Board and ensure all agreements are properly documented and signed off.
- b. Secretary

What the Bylaws say:

- a. Prepare draft agendas for Membership Meetings and Board Meetings for review and edits by the Board one (1) week before each meeting and distribute the final agenda to the Board at least thirty-six (36) hours before each meeting,
- b. Take minutes and maintain a record of the minutes of all meetings of the BOD and the Membership for a minimum of seven years, as required by law.
- c. Provide draft Membership Meeting minutes to the Board for review no later than seventy-two (72) hours after each meeting and provide final draft minutes to the Membership no later than one (1) week before the subsequent Membership Meeting for approval by the Membership at that meeting. If the minutes are not made available to the membership one (1) week before the meeting, the approval vote will be delayed until the next Membership meeting.
- d. Provide draft Board Meeting minutes to the Board no later than seventy-two (72) hours after each meeting for review and comments by the Board.
- e. Provide revised draft Board Meeting minutes to the Board including the comments received from Board Members no later than thirty-six (36) hours before the subsequent Board Meeting for approval by the Board at that meeting.
- f. Maintain an up-to-date roll of all members, including Membership Status, Membership and Cal South Training Meetings attendance.
- g. Review bylaws and other organizational documents to ensure continuing relevancy.
- h. Perform such other duties incident to the office as may be assigned by the BOD, or as required by law.

In addition to the duties specified in the Bylaws:

- a. Communicate decisions of the Board to individual members and membership applicants.
- c. Member at Large

What the Bylaws say:

a. Serve as the member representative to the BOD for concerns, questions, and suggestions regarding Association operations, including the design and conduct of surveys to obtain member feedback.



- b. Process all applications for membership in the Association received from prospective members and members wishing to renew their membership for the forthcoming Membership Year. Following deliberation and decision of the BOD, process membership applications and communicate the results to each applicant.
- c. Represent any member who appeals a BOD decision to a Grievance Committee, if requested by the member.
- d. Receive and review, in cooperation with the Assignor, all USSF or other match reports generated by SBSRA Referees for all Red Cards (Send-offs), serious injuries, game terminations or other unusual match incidents.
- e. Approve all match reports and forward the reports to the applicable party, as deemed appropriate by the BOD.

The Member-at-Large may not vote on members' disciplinary matters.

In addition to the duties specified in the Bylaws:

- a. Maintain an archive of all supplemental reports received and transmission of reports to the applicable leagues,
- b. Maintain and distribute an inventory of SBSRA items, e.g., badges, coins, t-shirts, law books.

Might you be interested in making our Association even better than it already is? If so, contact any of the incumbents or other Board Members to find out more about the specifics of each position.

Board candidate nominations are requested at our May meeting with Members-In-Good-Standing voting at the AGM.

 Bylaws Amendments – There are several opportunities for Bylaws amendments to be made. Any proposed amendment must be submitted in writing to the Board prior to the May General Membership Meeting and is voted on at the AGM.

#### From the Treasurer

Please be reminded:

- 1) Address Changes Provide me with your change of address at the same time as you make the change in Arbiter,
- 2) Cash checks received from the Association for games you officiated in a timely manner,
- 3) **Forfeits** Notify the applicable Assignor and me within 24 hours of forfeited games. This way they we can ensure the applicable league is billed the ref fees that would have been paid on the field and that the referees are paid the fees owing to them.

# SBSRA General Membership Meeting Minutes Tuesday, April 26, 2022

North Torrance High School, Cafeteria

**Board members present**: Jonny Joseph, Bruce Ashton, Gabriel Goldsman, Jack Desemone, Tim Martinez

- 1. Call to order at 7:33
- 2. Approval of March 2022 MM minutes Rick Roberts motioned to approve the March Minutes, Steve Resnick seconded the Motion, approved by acclimation.
- 3. SBSRA Training Free kicks, back to basics. Highlights of the training are as follows:
  - a. IFK Make sure your arm is up.
  - b. DFK When there are at least three defenders in the defensive wall, the opponents must be at least 1m/1 yard away from the wall.
  - c. High kicks with contact are a DFK, possibly SFP. Otherwise, it's an IFK for Dangerous Play. Remember, there is no foul "High Kick!"
  - d. Ceremonial Kicker needs to ask for 10 yards to create a ceremonial kick.
- 4. Treasurer's Report
  - 1. Financial Reports for the Quarter ended March 31, 2022 are on the website
  - 2. Address Changes same message as the last three months. Please inform the Treasurer in addition to making the change in your Arbiter profile.
  - 3. Cashing checks same as the last three months. Please deposit them in the bank ASAP!
  - 4. Forfeit reporting procedure Referees must notify the applicable Assignor and Treasurer preferably the same day as the game or within 24 hours. This way they we can ensure the applicable league is billed the ref fees that would have been paid on the field.
- 5. President's Report
  - a. Board Meeting Report April 2022

JJ reported that the following matters were discussed at this month's Board Meeting, many of which will be talked about in more detail in this meeting:

- i. Launch of the New Rating System,
- Futsal League start will be June 6 at LA Galaxy Soccer Center here in Torrance. We have a Futsal page in the "Competitions" section on our website with a lot of information and links to help us get going with this exciting new league for us. We had 52 members attend training during this past week and Gabriel will talk about that a little more.
- iii. AGM JJ asked the membership if they had a preference for the type of meeting to be held. For example, we had a food truck in 2021 and previously held our AGMs at pizza places. Following a hand vote, it was decided to return to a restaurant setting. Members were then invited to suggest locations that were central for all members (near North High). Jack Desemone suggested Metro Café, in El Segundo, the membership liked the idea, JD will follow up on the food to be served and a budget to determine if this is feasible for us.
- b. Annual General Meeting
  - i. Location and Dinner see above
  - ii. Board Elections President, Secretary, Member at Large see above



- iii. Bylaws Amendments JJ reminded the Membership that any proposed changes must be submitted, in writing, prior to/at the May meeting according to the Bylaws.
- c. New Leagues Futsal at LA Galaxy Soccer Center in Torrance starts on June 6 and ZogSports returned on April 24 at Santa Monica College. We were successful in increasing Zog match fees from \$30 per game to \$45 per game!
- d. New Member Introductions There were no new members.
- e. SafeSport Refresher JJ reported that he completed the Third Refresher course after receiving email notification that his certificate would be expiring soon. It was easy to do but requires a good hour or so to complete. Not all members received a reminder email, but it needs to be done before the current one expires to receive games.
- 6. Vice President's Report In SM's absence, JJ presented SM's report:
  - a. New Ratings System Update

Last week the Ratings Team, led by Steve, held their first Zoom meeting of observers to discuss and review their written observations for referees conducted over the prior two weekends,

- i. Number of Members Observed
  - 1. Observed 12 members
  - 2. Created a Dropbox to share observations
- ii. Post-Game Debriefs
  - 1. Find 3 positives to discuss
  - 2. Find 3 opportunities to improve
- iii. Next Steps Meeting scheduled for next week to start discussing the rating impacts of the observations
- b. Cal South ROL we have 122 SBSRA members on the 2022 ROL
- 7. Assignor's Report
  - a. CORE GG reported that there was a record attendance of over 100 people at the April training! In addition, he noted there were 27 attendees at the New Referee Training which So Cal holds simultaneously on the same field. GG noted that Juan Guzman, State Referee Administrator publicly thanked SBSRA for securing North High for these important training sessions.
  - b. Futsal Training GG reported that we had 52 attendees at the trainings held over the past week. We are working with the LAGSC to schedule a scrimmage that our members can observe and discuss the league rules after the game.
  - c. Tournaments Memorial Day weekend we will assist another association with referees for a tournament, and SBSRA will be the host association for a tournament on the weekend of July 23<sup>rd</sup> and 24<sup>th</sup>.
  - d. Reporting Scores GG reported that he is not receiving scores for Zog games and SBPSL match reports. The CR needs to scan the SBPSL match report, preferably in PDF format, and send them to the Assignor on the same day as the match. Also, GG reminded the membership to pull cards (depending on the league requirements) and do supplemental reports, especially for SBPSL.
  - e. Accepting Assignments GG reported that he has experienced many times where people will sit on games, i.e., after the games are assigned in Arbiter, members will open Arbiter but not accept or decline the games, and then return them late. When you receive the games, please accept or decline them without delay.



- f. Blocking Leagues It was brought up that Arbiter does not allow members to block leagues. GG said that if you don't want to work a certain league, send him an email. Arbiter does allow one to block the following:
  - i. Sites,
  - ii. Teams
  - iii. Partners
  - iv. Travel Limits
  - v. Postal Codes
- 8. Other Business Members were invited to get SBSRA jersey badges and coins from TM and JJ had Law Books and Dry Fit shirts for those who had ordered them.
- 9. Meeting adjourned at 8:47.


